### A letter from the **Foundation Board President**

# Dear Vantage Point Residents and Friends:

Greetings, and thank you for your part of our shared sacrifices during the past months of the pandemic. Now let me get right to the point. When we ask people to empower the Vantage Point Foundation with their funds, we usually hear these two questions. First, what has the Foundation been doing to support the residents of Vantage Point? Second, if I make a gift to support the Foundation, how can and will my funds be used?

These are fair questions. This report is designed to answer them, and to thank once again the many donors who have already supported the Foundation. This year, the Foundation Board has realigned our endowment into three funds. The Vantage Point **Community Support Fund** enhances **facilities and programs** for the benefit of all residents. For example, this year we

funded the Vitascan Bladder Scanner to reduce the number of trips to the hospital. We have also funded a freshening of the Cedar Place public areas, but the results won't show until the pandemic is over. The **Staff Support Fund** helps **staff members** with their career growth, and in times of family tragedy. The **Resident Support Fund** helps **individual** residents in personal financial need.

You can choose to designate your gift to support any one or more of these endowments. Undesignated gifts are put toward the areas of greatest need at the time. We also anticipate periodic capital campaigns. Many rooms and areas at Vantage Point can be named in honor of someone you love. Please ask us about this opportunity. The Foundation also facilitates non-endowed gifts that can support initiatives that are important to residents, like Sidwell Garden as well as social and cultural events.

The year 2020 has reminded us painfully that it takes heart and courage to move through these difficult times. It also takes money. Beyond entrance deposits and monthly fees, Vantage Point needs money to build and enhance for the future in a planned way, to hold down the annual increases in monthly fees and to make it through unplanned hard times, such as the pandemic. We ask for your generous help with these goals. For 2020 only (unless extended by Congress), you can give up to \$300 to charity and deduct it *even if* you are taking the standard federal tax deduction.

I am grateful for your taking the time to read this comprehensive report. May you come away with a greater understanding of the Foundation. May it lead you to reflect on who, and what, are important in your life and worthy of your help.

2020-2021 FOUNDATION REPORT

## FY2020 **Key Accomplishments**:







The Board created the inaugural Legacy Society recognizing resident and family gifts of \$1,000. Once a resident/family is a Legacy member, recognition is in perpetuity.

The Board allocated over \$85,000 from the Foundation endowment fund to support the following key initiatives:

- \$52,000 toward new Cedar Place flooring and new furniture and décor in the Cedar Place Activity Room
- \$6,200 toward Hearthstone re-certification
- \$8.600 toward staff COVID bonus
- \$10,000 toward the new "Live Where You Work" program
- \$10,000 toward purchasing the Vitascan Bladder Scanner

The Foundation raised \$17,025 with gifts from both the 13 Legacy Society Members and additional resident community donations to grow the Foundation endowment as well as support the Cedar Place décor improvements.



The Board developed and approved the first Columbia Vantage Point Foundation mission, vision and core values statements, along with the first Strategic Plan covering the period 2019-2022.






The Board established the Resident Outreach




### FY2020 Cash + Investments

## Columbia Vantage Point Foundation **Historical Investments**



The Residents Association has been essential in helping to grow the Foundation endowment over the past decade. A combined \$400,000 was shifted to the Foundation endowment giving the Foundation operational oversight of the Residents Assistance Fund in 2018.

### The Path Forward

We happily celebrated the 30th anniversary of Vantage Point in October 2020. Today, as we look forward to FY2021, we recognize the critical importance of educating residents and families on the Foundation's purpose of providing financial support for the current and future Vantage Point community.

The Board will be looking to more significantly increase funds in FY2021 and beyond to grow the following three primary endowments, which are a reallocation of the RESS fund:

- 1 Vantage Point Community Support Fund: Enhancing Vantage Point community facilities and programs.
- 2 Staff Support Fund: Supporting staff development and emergency needs.
- **Resident Support Fund:** Supporting individual resident needs.

Currently these three endowments total \$780,192 and it is the year-to-year growth (approximately 4%-5%) that is allocated to significant initiatives like the \$52,000 Cedar Place upgrades from the Community Support Fund. The Staff Support Fund supports both

employee education and recertification, along with the new "Live Where You Work" program where the Vantage Point Foundation and The Columbia Downtown Housing Corporation will subsidize two downtown Columbia apartments in 2021 so the eligible employees can live near Vantage Point.

Importantly, heartfelt gifts to the Foundation's endowment make a significant difference in the amount of money that the Foundation can allocate to support the current and future VP resident community. These types of gifts, managed with a financial planner, can be made through a will, living trust or dedicating a percent of the resident entrance deposit refund to be left to the Columbia Vantage Point Foundation.

The Foundation will also be looking to establish shorter term restricted funds to recognize the legacy of residents to support social and cultural events like music performances, fine arts shows, educational speakers, and the like. We will also continue to fundraise for the Sidwell Garden fund.

The Board and Resident Outreach Committee are looking forward to working with Vantage Point residents and their families, along with the surrounding community, to raise funds to grow the Foundation endowment and shorter term legacy funds.
